This third prospectus supplement (the "Supplement") which has obtained visa n°20-067 on 3 March 2020 from the *Autorité des marchés financiers* (the "AMF") is supplemental to and must be read in conjunction with the base prospectus dated 1 July 2019 granted visa n°19-305 on 1 July 2019 by the AMF as supplemented by the first prospectus supplement dated 16 October 2019 granted visa n°19-493 on 16 October 2019 and the second prospectus supplement dated 9 January 2020 granted visa n°20-005 on 9 January 2020 (the "Base Prospectus"), prepared by the *Caisse d'Amortissement de la Dette Sociale* ("CADES" or the "Issuer") with respect to the Euro 65,000,000,000 Global Medium Term Note Programme (the "Programme"). Terms defined in the Base Prospectus have the same meaning when used in this Supplement.

This Supplement has been prepared pursuant to Article 16.1 of Directive 2003/71/EC, as amended by Directive 2010/73/EU (the "**Prospectus Directive**") and Article 212-25 of the AMF's General Regulation.

By virtue of this Supplement, CADES is providing updated information on its rating outlook provided by Moody's France S.A.S.

Copies of the Base Prospectus and this Supplement will be available, during usual business hours on any weekday (Saturdays and public holidays excepted), for inspection by Noteholders at the specified offices of the Fiscal Agent and will be available without charge (i) on the website of the AMF (www.amf-france.org) and (ii) on the website of the Issuer (www.cades.fr).

Save as disclosed in this Supplement, there has been no other significant new factor, material mistake or inaccuracy relating to information included in the Base Prospectus which is capable of affecting the assessment of Notes issued under the Programme since the publication of the Base Prospectus.

To the extent applicable, and provided that the conditions of Article 212-25 I of the AMF's General Regulation are fulfilled, investors who have already agreed to purchase or subscribe for Notes to be issued under the Programme before this Supplement is published, have the right, according to Article 16.2 of the Prospectus Directive and Article 212-25 II of the AMF's General Regulation, to withdraw their acceptances by no later than 5 March 2020.

To the extent that there is any inconsistency between (a) any statement in this Supplement and (b) any other statement in the Base Prospectus, the statements in this Supplement will prevail.
